

METADATA ON 2021 LABOUR FORCE SURVEY

1. PRODUCER

Labour Force Survey, 2021 was conducted by National Statistics Bureau (NSB) and funded by Royal Government of Bhutan.

2. METHODOLOGY

Survey questionnaire: The 2021 LFS questionnaire contains the following sections:

- Basic Demographic information;
- Education Details;
- Participation in the Labour Force;
- Employment characteristics;
- \cdot Unemployment and not in the Labour Force characteristics; and
- Previous Employment history

In order to maintain comparability, most of the questions that were canvassed in previous LFSs were retained. There were 6 sections in the questionnaire and it was prepared in consultation with the relevant stakeholders. The content of the questionnaire were in coherence with the international standards as well as in sync with the requirements of the national needs. In order to determine the average time taken, flow and relevancy of the questions, the questionnaire was pretested in three regions.

Reference period

Different reference periods were used for different indicators based on the ILO recommendations.

- \cdot The reference period for employment was one week prior to date of enumeration.
- \cdot The reference period for Looking for work was one month prior to the date of enumeration.
- \cdot The reference period for available for work was within two weeks after the date of enumeration.

Target population, sample size and sample allocation:

The LFS has been designed to cover the regular households of the entire country. The sample for 2021 LFS was designed to provide estimates of the labour force related indicators both at the national and the dzongkhag levels.

The total sample size for 2021 LFS was 10,130 households at the national level. The estimated sample size at each dzongkhag was then allocated proportionally to urban and rural areas. At the national level, 32% (3,230) of the total sample size is allocated to urban areas and 68% (6,900) to rural areas. From the 10,130 sample households, 10,076 households responded to the survey questionnaire, giving a response rate of 99.5%.

A stratified two-stage sampling design was adopted, where EAs in urban areas and chiwogs in rural areas formed the Primary Sampling Unit (PSU). Probability Proportional to Size with Replacement (PPSWR) was used to select PSUs in both urban and rural areas with the number of households as size of variable.

The households within each PSU formed the Secondary Sampling Unit (SSU). Circular Systematic Sampling (CSS) was used to select SSUs in each selected PSU.

In order to estimate the required sample size, a criterion variable was decided upon which the estimation was based. It was decided that the estimation of the required sample size be based on the Youth Unemployment Rate. For the reasons of comparability and consistency, the same sample size determination method and sample size was maintained. However, the observation may vary due to the member composition of the selected household during the field enumerations since the household selected during this survey may differ from that of previous surveys.

The required sample size for each dzongkhag was estimated using data from the 2017 LFS on the Youth Unemployment Rate in each. The formula for sample size is as follows: where:

- \cdot n is the number of households required in the sample
- \cdot z is the value of the statistic in a normal distribution for a 95% confidence interval
- \cdot p is the youth unemployment rate in the dzongkhag
- \cdot e is the acceptable margin of error in estimating p; set at 0.05
- \cdot f is the sample design effect, assumed to be 2.0
- \cdot k is the adjustment factor for an anticipated non-response of 5%

3. QUESTIONNAIRE

The questionnaire for the 2021 LFS is attached as Annex

4. DATA COLLECTION

The enumerators and supervisors were divided into 21 teams based on the sample size and the geographical locations of PSUs in the dzongkhag. Each team was led by a supervisor from the respective dzongkhag and an official from NSB and was deployed to the field for a period of 23-30 days. For the reasons of comparability, the LFS field data collection is conducted in the month of November - December every year.

Data was captured during a single visit to the household. In cases where a head of household or competent member of households could not be contacted during the first visit, a minimum of three revisits were made. The data collection was conducted using Computer Assisted Personal Interviewing (CAPI) method on the survey solution systems.

5. DATA PROCESSING

The field data collection was done using CAPI method. The questionnaire was designed in the survey solutions application. The data consistency checks were done by the respective supervisors during field enumeration, while the coding and revalidation were done by data coders at the head office.

The data validation, cleaning, and tabulations were done for the duration of three weeks using statistical software Stata Version.17. The sampling weights were developed and assigned to individual households in order to obtain the estimates for the whole country. The analysis was based on 10,076 households with 40,830 persons of which 29.6% are in urban and 70.4% are in rural areas.

6. SURVEY KEY FINDINGS

6.1. Economically Active and Inactive Population

The working-age population is estimated at 489,732 persons; 238,310 (48.7%) males and 251,422 (51.3%) females. About 34% of the working-age population are in urban areas and about two-third are in rural areas.

Of the total working-age population, 338,376 persons are economically active out of which 51.5% are males and 48.5% are females. By area, 67.8% of the total labour force resides in rural area, while a little less than one-third (32.2%) live in urban areas.

The Labour Force Participation Rate (LFPR) for Bhutan is estimated at 69.1%. The LFPR for rural area (71.1%) is higher than urban area (65.3%). Comparing by sex, the LFPR for male is (73.1%) higher than female LFPR (65.3%).

About 31% (151,356 persons) of the working-age population are economically inactive; more than half (57.6%) are females, while 42.4% are males. A little less than two-thirds (61.7%) of the economically inactive population are found in rural areas and 38.3% are in urban areas.

6. 2. Employment

The country's employment rate is 95.2%. The employment rate for males is 96.4% and 93.9% for females. Of the total employed (322,122 persons) 222,766 are in rural areas and 99,356 are in urban areas. Samdrup Jongkhar Dzongkhag has the highest employment rate with 99.0%, while Thimphu has the lowest (89.9%).

By major occupational groups, "skilled agricultural, forestry and fishery worker"1 (48.7%) employed the highest number of persons, while "armed force occupation" (1.6%) employed the lowest. Employed persons working as "regular paid employee" (28.1%) accounted the largest proportion of the employed persons, followed by persons working in agriculture as "family worker" (26.0%) and persons working in agriculture as "own account workers" (22.6%).

Out of the total employed persons, 41.5% are without any qualification, while about 16.0% has "lower and middle secondary" and 11.5% has "primary" level of education. About 8.6% of the employed persons has education level of "bachelor's degree and above".

Among the total employed persons, the highest percentage is engaged in the agriculture sector (49.2%), while the lowest is in the industry sector (14.1%). The share of employment in service sector is 36.6%. Comparing by age group, 14.6% are in the age range 30-34 years, and it is closely followed by 13.9% in the age range of 35-39 years and 12.7% in 40-44 years.

6. 3. Unemployment

A total of 338,376 persons are classified as economically active or in the labour force. Out of these, 16,254 persons were without work, seeking and available for work during the reference period. This translates to an unemployment rate of 4.8%.

The unemployment rate for females (6.1%) is higher than that for males (3.6%). Unemployment is more of an urban phenomenon with 8.9%, which is almost three-times higher than that of rural areas (2.8%).

Among dzongkhags, Thimphu has the highest unemployment rate at 10.1%, followed by Paro (7.7%), Haa (6.1%), Punakha (5.1%) and Chhukha (4.8%), while Samdrup Jongkhar (1.0%) has the lowest unemployment

rate, followed up Bumthang, Dagana, Gasa and Zhemgang Dzongkhags with the unemployment rate of 1.5%.

The overall youth unemployment rate is estimated at 20.9% (6,492 persons). Out of the total unemployed youth, about 38.6% are males and 61.4% are females.

The long-term unemployment rate is estimated at 1.9% (6,552 persons). The rate is higher among females (2.5%) than males (1.4%)

The second column gives the label of the variable. It describes the variable in few words. The third column describes each variable in detail.
