Background

The NSB as the central authority for collection and release of any official data and their custodian, is mandated to conduct national surveys and censuses, publish statistical reports, validate and maintain a data repository of the country, ensure statistical standards, provide technical supports to streamline and strengthen the statistical system in the country.

The key challenges identified through the assessment of the National Strategy for the Development of the Statistics highlights data gaps related to quality, frequency and disaggregation. Further, it underlines the need for adequate statistical infrastructure including office space, predictive analytics system and statistical policy.

Plan Priorities

In this regard, the NSB shall conduct national surveys and censuses to generate high frequency data and statistics and enhance quality of administrative data. The NSB shall improve data methodology by adopting data integration techniques, foresight capabilities and big data analytics. The NSB shall make efforts to ensure adequate statistical infrastructure including office space, predictive analytics system and statistical policy. Further, the NSB shall provide statistical and technical supports and create data literacy among the data users.
