This bulletin covers price developments across major sectors of the economy, including Forestry & Logging, Mining & Quarrying, Manufacturing, Electricity, Gas, Steam & Air Conditioning Supply, Transport, and Information & Communication. It focuses exclusively on prices of goods and services produced domestically.

The NSB extends its sincere appreciation to all government agencies, corporate entities, and private sector organizations for their continued cooperation and timely provision of data. Your invaluable support has played a vital role in the successful compilation and publication of this bulletin. We look forward to your continued collaboration in future statistical undertakings.

# **Highlights**

#### **Year-on-Year Inflation**

Year-on-Year (Y-o-Y) inflation for April, May, and June 2025, as measured by the Producer Price Index (PPI), stood at 1.35 percent, 1.18 percent, and 0.51 percent, respectively. This corresponds to an average annual increase of 1.01 percent in the second quarter of 2025 compared to the same quarter of the previous year.

In the second quarter of 2025, the Transport sector and the Electricity, Gas, Steam, and Air Conditioning Supply sector were the major contributors to the rise in overall inflation. The Transport sector experienced significant price increases, registering 3.82 percent, 3.70 percent, and 3.93 percent in April, May, and June respectively. This increase was primarily driven by public transport and postal service, both domestically and internationally.

The Electricity, Gas, Steam, and Air Conditioning Supply sector registered a consistent Year-on-Year inflation rate of 3.58 percent during the quarter. This increase was primarily driven by the revision of energy charges effective from 1<sup>st</sup> November 2024, which contributed to sustained higher producer prices within the energy sector.

On the other hand, the Manufacturing and Mining & Quarrying sectors exerted downward pressure on overall inflation. The Manufacturing sector posted YoY deflation of -1.06 percent, -1.38 percent, and -3.52 percent across the three months, primarily due to declining prices in manufacture of food products, beverages, non-metallic mineral products, manufacture of chemical & chemical products and basic metals.

Similarly, the Mining and Quarrying sector recorded year-on-year price declines of 0.52 percent, 0.81 percent, and 0.60 percent, primarily driven by decrease in coal and other mineral product prices. The Forestry & Logging and Information & Communication sectors showed no year-on-year price movement, indicating continued stability in these sectors compared to the same period in 2024.

#### Month-on-Month Inflation

Month-on-month (M-o-M) inflation reflected minor fluctuations throughout the first quarter. The overall index declined by -0.03 percent, -0.12 percent, and fell further to -0.62 percent in April, May, and June respectively.

The Manufacturing sector recorded a 0.22 percent increase in April, followed by decrease of -0.25 percent in May and -2.01 percent in June. These changes reflect short-term adjustments in raw material costs and producer pricing strategies.




**Graph 1: Month-on-Month Producer Price Index (PPI)**

# **Technical Notes**

#### **Definition**

Producer Price Index (PPI) is the measure of average change over time in the prices received by the domestic producer of goods and services. It shows the average change in the prices of goods and services with reference to a particular reference period known as Index reference.

# **Scope and Coverage**

The PPI covers domestically produced goods and services that are destined for domestic as well as export markets. The sectors included are logging, mining and quarrying, manufacturing, utilities (electricity and water), transport, and the Information & communication sector. PPI is classified and compiled by activity (BSIC rev. 4) and also by product (CPC rev. 2).

#### Reference Period

There are three "reference periods" used for PPI as given below:

- i. Weight Reference- is the period during which Economic Census of Bhutan (ECoB) 2017 which is carried out by the National Statistics Bureau (NSB). The weight-reference period for the new PPI is 2017, that is, the period when the ECoB was conducted.
- ii. **Index Reference** is the period when the index is set to 100. In the new PPI, the index reference period is January 2022.
- iii. **Price Reference** is the period for which the prices of each product are used for calculating the elementary indices (indices for individual PPI items). The price reference period for the new PPI is January 2022.

#### **Price Collection**

Point-in-time prices are collected for the PPI compilation i.e. price of a product on the15th day of every month or the nearest trading day to the 15th of the month

## Index calculation methodology

Geometric Modified Laspeyres's formula is used for compiling PPI

$$P_{gyo} = \prod_{i=1}^{n} \left(\frac{P_i^t}{P_i^0}\right)^{w_i^0}$$

#### Uses of PPI

- 1. As deflator in National Accounts to estimate the real growth rate
- 2. As a lead indicator of inflationary trends
- 3. Indexation of cost escalation in long-term contracts of goods and services
- 4. Business Analysis
- 5. Current cost accounting

# **Calculating Index Changes**

Movement of the Price index from one month to another is usually expressed in terms of percent changes, rather than as changes in index points. Index point changes are affected by the level of the index in relation to its base period, whereas percent changes are not. The following example shows the computation of index points and percent changes.

# Index point change

All industry's Price Index	104.50
The less previous price index	101.25
Equals index point change	3.25

# Index percent change

Index point change	3.25
Divided by Previous Price Index	101.25
Equals	0.032
Result multiplied by 100	0.032 x100
Equals percent changes	3.2

# **Revision Policy**

If the data are not received on time from the sources, the index published for that particular quarter are marked as "Provisional" and it is revised and finalized when the next quarter index is published.
