## 1.1 Introduction:

Bhutan Living Standard Survey (BLSS) 2003 is a nation-wide survey of households undertaken by the National Statistical Bureau. BLSS 2003 is an improved version of the Pilot Household Income and Expenditure Survey (HIES) 2000. The BLSS followed the LSMS methodology developed by researchers at the World Bank. However, based on the unsatisfactory income data as evidence from the HIES 2000 the survey was designed to collect only consumption expenditure from the household to assess people's well-being and to construct comprehensive poverty profile for the country. Apart from collecting basic information about each household, the BLSS collected information on housing, employment, health status, fertility, education, access to public facilities, assets ownership, accompanied by a community questionnaire aimed at collecting information on service provision and prices of commodities. The information collected in the survey will enable the government to assess the effectiveness of the present policies and programmes on the living conditions of different sections of population and identify households that need assistance to formulate specific policies and programmes.

## 1.2 Objectives of the BLSS:

The broad objective of the survey was to collect detailed information about the economic and social conditions of households. Besides, the survey also addressed the following specific objectives:

- To provide useful inputs for the compilation of national accounts of the household sector as well as statistics of household expenditure and consumption pattern.
- To provide benchmark information on household consumption expenditure to update weights required in the rebasing of consumer price indices.
- To provide inputs in the estimation of the poverty profile for the country and various poverty indicators.

## 1.3 Scope and Coverage:

The BLSS collected data on

- Household assets, housing, consumption expenditure and access to utilities
- Demographic characteristics of the household members
- Health, education and employment status of all household members
- Remittances sent by the household
- Prices of different commodities paid in the local market

The geographical coverage extended over the entire area of Bhutan excepting a few satellite towns, which are neither identified as urban areas nor under the administrative control of gups and chupen in the rural areas. Also due to security reasons the rural area in Sarpang and Samdrup Jongkhar Dzongkhags were not covered in the survey. Therefore, the BLSS covered 86 gewogs from eighteen Dzongkhags and 27 urban settlements including the towns of Sarpang, Gelephug and Samdrup Jongkhar.

The population coverage included all households in the country except the following:

- Diplomatic and expatriates households
- Residents of hotels, boarding and lodging houses, monasteries, nunneries, school hostels, orphanages, rescue homes, and under trails in jails and indoor patients of hospitals, nursing homes and
- Barracks of military and Para-military forces including the police

## 1.4 Survey Methodology and Sample Design:

The Bhutan Living Standard Survey followed the Living Standard Measurement Survey (LSMS) methodology developed by researchers at the World Bank. The methodology has been customized for Bhutanese population and collected information through an integrated household questionnaire covering consumption, assets, housing, education, health, fertility, accompanied by a community questionnaire aimed at collecting information on services and prices of the common commodities.

The Survey and Data Processing Division of the National Statistical Bureau maintains an updated list of households by gewog for the entire country. Mapping of the urban centers was conducted and a sketch map was drawn for all the urban centers included in the survey prior to the block selection.

The sample size for the BLSS was determined using the information relating to the coefficient of variation (CV) of some key expenditure variables as recommended by the United Nations Statistical Office based on the log-normal distribution of key expenditure variables. Keeping in view the uses of the survey results, it was felt that sampling precision of 5 percent at the national level would serve the purpose of the survey. Taking the assumption, it was derived that n, the sample size required for estimating the population mean y with 95 percent confidence.

## $n = 1600(CV)^2$

Taking into account of the CV of 1.0492 for the log-normal distribution and design effect of 2 for a stratified multi-stage sampling design, sample size of 4200 distributed to urban and rural with provisions for some non-response households was determined.

In order to get a representative sample of the households the entire country was divided into three regions based on the number of households and their geographic location; namely Western, Central and Eastern.

**Western Region:** Thimphu, Paro, Ha, Samtse, Chhukha, Punakha and Gasa **Central Region:** Wangduephodrang, Daga, Tsirang, Sarpang, Zhemgang,

Trongsa and Bumthang

**East Region:** Lhuntse, Mongar, Pemagatsel, Samdrup Jongkhar,

Trashigang

and Trashi Yangtse

The different areas were divided into seven strata. Each stratum composed of four urban strata (Thimphu city, rest of Western, Central and Eastern) and three rural strata (Western, Central and Eastern) has been designed to yield 600 households. Two rural areas of Sarpang and Samdrup Jongkhar were dropped out in the sample due to security reasons. The final sample size for the survey was 4120 households. The distribution of the sample household is shown in table 1.1.

The urban areas were divided into number of blocks. Each block was formed with a well-defined boundary and number of households ranging from a low of 100 households to maximum of 300 households. Gewogs in the rural area and blocks in the urban area were treated as enumeration areas and thereby the primary sampling units (PSU). The PSUs were selected based on probability proportional to size for both urban and rural areas. Within the selected PSUs a total of 20 households and 10 households were selected based on systematic circular sampling scheme for the Gewogs and blocks respectively.

## 1.5 Survey Instruments used

There were four main sets of questionnaires/schedules used for the BLSS 2003, two for the listing of households for the sample selection (one each for urban and rural) and the other two for the collection of data on household consumption expenditure and prices at the community level. The main household questionnaire for the collection of consumption expenditure data was divided into ten homogenous sections, called blocks.

Each block collected detailed information for a specific subject/topic of interest. Some of the blocks were further divided into sub-blocks according to the nature of the topic covered. The list of instruments used for the BLSS 2003 is as shown in the Box 1.

The Survey and Data Processing Division of the NSB prepared two comprehensive manuals:

- **Interviewer Manual:** this manual was prepared for the enumerators. It contained the basic concepts and definitions of different items of information, procedures for interview and instructions for (i) listing of households, (ii) selection of sample households, and (iii) recording information in each of the blocks and sub-blocks of the questionnaire.
- **Supervisor Manual:** This manual was prepared for the supervisors. The manual provided detailed instructions for (i) undertaking rationalized supervision of fieldwork, (ii) ensuring quality of data and (iii) selection of sample households in the urban and rural area.

In addition to the two important instruction manuals there were few special documents prepared as reference materials for the field operators. The documents included (i) age conversion table from Bhutanese to English, (ii) Unit conversion table from local units to standard international unit, (iii) table of International Standard Industrial classification (ISIC) and International Standard Classification of Occupation (ISOC) codes.

#### 1.6 Reference Period

Keeping in view the data collection technique to be used for the survey different reference periods have been defined for different purposes. To get the population estimates of the sample households the members of the households were identified on the basis of their "usual place of residence". For the purposes of this survey, "usual" is taken to mean that the person concerned has lived in the household for at least six months of the year. In order to get an estimate of the household's average food consumption expenditure, a reference periods of last two weeks and a typical month were taken. Although a reference period of last two weeks could have provided a good estimate of the food consumption expenditure the typical month data would substantiate the expenditure by providing data on the consumption of items not available during the last two weeks of the survey period

but the household consumed the items when it was available. The reference period for both durable and non-food items were used as last twelve months

#### 1.7 Training of Supervisory staff and Enumerators:

The NSB then the Central Statistical Office recruited a group of 66 enumerators for conducting the fieldwork of the survey. A majority of the enumerators selected were under graduate who had written the final year examination from Sherubtse college and a few 12th grade students waiting for their scholarship.

The training sessions was divided into two groups. A weeklong training was conducted specifically for the staffs of the NSB who supervised the field operation of the BLSS. The training imparted instructions and skills to carry out the sampling procedures and mapping of the urban centers. It also discussed the questionnaire in detail. The supervisors were also familiarized on the use ISIC and ISOC codes for the industries and occupation respectively.

The enumerators training was conducted from March 26<sup>th</sup> to 5<sup>th</sup> April 2003, for two weeks. All the fourteen supervisors were the basic trainers at the program. The survey coordinator ensured that every enumerator and supervisor was provided with the instruction manual and the important documents. The general pattern of the first week training was that after a section of the questionnaire had been presented, using visual aids by the main trainer, the interviewers broke up into pre-assigned groups, under the direction of a supervisor to discuss the section in more detail. The composition of the groups changed from day to day, so that enumerators were forced to interact with as many different interviewers and supervisors as possible. Interviewers took turns in interviewing each other to become familiar with the questionnaire. The problems encountered were discussed in plenary session and resolved before moving on to the next section.

At the end of each day's training every enumerator was asked to collect data for their own household for the completed sections of the questionnaire. The questionnaires filled-in by the enumerators were thoroughly scrutinized by the group supervisors and the problems noted were pointed out to the concerned enumerators and discussed in plenary sessions. A particular day was assigned to conduct a field practice of the household interview. Filled-in questionnaires were collected from the enumerators and checked by the group supervisor to ensure that enumerator completely understood the concepts and data to be collected. The problems were discussed in the question answer sessions.

## 1.8 Field Operation:

Prior to the field operation the NSB ensured that the public was informed about the BLSS. Public awareness were created through a series of announcement through Bhutan Broadcasting Service radio broadcast and the Kuensel (weekly newspaper), Besides, all the Dzongkhag (district) officers were informed about the time schedule of the BLSS field operation. The NSB also requested the Dzongkhag administration to issue instructions to all Gewog (block) officers to extend full cooperation to the survey team. Each enumerator was given a letter signed by Secretary, Planning Commission introducing him/her and ensuring confidentiality of the information to be provided by the household.

A total of 90 field operators (24 NSB Officials and 66 enumerators) were divided into fourteen teams, each headed by a supervisor and an assistant supervisor. The officials of the NSB were the main supervisors during the filed operation. Each team was provided with a vehicle to facilitate smooth field operation. The field operation started on 5th April and was completed on 30th June 2003. The supervisor accompanied the enumerators throughout the survey and conducted field edits. The survey coordinator visited the

teams and verified the problems encountered by the enumerators during the field operation.

#### 1.9 Response Rates:

There were non-responses despite the best efforts made by the enumerators and supervisors. A household was treated as non-response after three revisits. The overall response rate was 97.3 percent with 96.6 percent and 98.1 percent for urban and rural areas respectively. Some of the main reasons reported by the field staff for non-response were failure to establish contact with any adult family member in the household in spite of at least three attempts. This was found common in both urban and rural areas. There were a few cases of refusal to cooperate particularly in the urban areas. In most of the cases the concerned supervisor made sincere efforts to convince the head of the household by explaining the merits of survey results at the end. The head of the household was assured that the data collected would remain confidential and no way their household status be revealed to the public. The response rate for urban and rural areas is shown in table 1.2.

## 1.10 Data Processing and Analysis:

After the completion of the field operation the filled-in questionnaires were reviewed by a group of trained manual editors under each supervisor. A manual scrutiny manual was prepared and distributed to the group of manual editors and the supervisors.

The data entry application was designed using CSpro software under the guidance of a technical assistance and the programmers of NSB. The office recruited 15 temporary staffs to carry out the manual scrutiny and data entry. Manual scrutiny and data entry of the BLSS was completed at the end of September 2003. Computer editing, validation of the data and analysis began at the beginning of October 2003.

#### CHAPTER - II

#### DEMOGRAPHIC PROFILE OF THE SURVEY POPULATION

#### 2.1 Estimate of survey population

It may be noted that unless otherwise stated the estimate of the population and number of households will refer to "Survey Estimate". The survey covered a total sample of 4007 households accounting to 19428 persons. Table 2.1: presents the estimate of population by age and sex separately for each of urban, rural and Bhutan. This sample represented a total extrapolated population of 547178 people and 106869 households. This figure is an estimate based on the sample frame, which does not cover whole population of the kingdom. The overall sex ratio of the survey population worked out to 93 males for every 100 females. Of the total survey population 19 percent represented urban.

## 2.2 Age Dependency Ratio

The age dependency ratio of the surveyed population had been partially based on the United Nations concepts and on the Bhutan civil service rules. The lower age group of the dependent children have been fixed at 14 or less years of age as per UN recommendation and the upper age group have been fixed based on Bhutan Civil Service rules, which states that it is mandatory to retire from the services at sixty years of age. Therefore, the age dependency ratio is defined as the ratio of persons in the "dependent" ages (under 15 and over 60 years of age) to those in the "economically productive " ages (15 to 59 years of age) in the population. Age dependency ratio indicates the burden that needs to be shouldered by potential working population. Surveyed population by broad age groups in table 2.2 showed that 35 percent of the population is under 15 years of age, 56 per cent of the population in the productive age and 9 per cent above 60 years or more. The overall dependency ratio is 79 with 72 and 80 for urban and rural areas respectively. Table 2.2 show dependency ratio for different areas by sex.

## 2.3 Household Composition and Relationship to Head

Family ties are very strong in Bhutan and members support one another in times of illness, death and other adversity. Extended family is the predominant system in Bhutan and older persons usually nurture the family and take care of the younger children (CEDAW report). The average size of a household is estimated to be 5.12 with 4.32 and 5.36 for urban and rural areas, respectively. Table 2.3, present the household composition of the surveyed population. The surveyed population showed strong relation with the existing family structure. However, it is seen that trend is slowly changing in the urban areas as evidenced by the lesser percent of household composition with members other than the couple and children.

In Bhutan both men and women who work for the household make most household decisions jointly. These include decisions about education of children, purchase or sale of goods and services and marriages of sons and daughters (CEDAW). However, it has been found that most of the households willingly state the elder member of the family as head. Table 2.4, present the head of households by sex for urban and rural areas and showed that female head constitute about 31 percent. From table 2.5, it could be seen that most of the head of the households are among the active work group between (20-59) years of age, constituting more than 75 percent.

Marriages in Bhutan result in the exchange of work force between families. Sons are usually sent out in marriages, while daughters stay home. Daughter's marriage is considered to bring in an additional worker in the family, most families favour early marriages for girls. Although, many choose their own partners, arranged marriages still occur in rural areas (CEDAW). From table 2.6, it could be seen that marriages below the

age of 15 years of age is almost negligible and exist only with females. Most of the married persons are between (20-39) years of age.

#### CHAPTER - III

#### **EMPLOYMENT STATUS**


For the purpose of this report, a person was classified as employed if the person worked in any of the activities like farming, hunting, fishing, or gathering of fruits, worked for pay, or as any unpaid worker in household enterprises during the seven days prior to interview and persons with jobs but not working during the reference period. Persons who did not work during the seven days prior to interview but was available and looked for work, or did not look for work due to the following reasons; waiting for a job to start, awaiting employer's reply, waiting for seasonal jobs and other reasons were considered unemployed. All others who did not work or did not look for work for reasons like currently studying, taking care of home, too old or disable or not healthy and pensioner and doesn't want to work were treated as inactive. (Caution:- It should be noted that the BLSS is different from standard labour force survey due to relatively small sample size, the results should be analyzed with extra care.)


#### **CHAPTER - IV**

#### LITERACY AND EDUCATION

According to this survey individuals were considered literate if they reported that they were able to read and write at least in any one of the languages (Dzongkha, English, Lhotsham or others). However, no literacy test was administered for the literate persons. From table 4.1 it could be seen that overall literacy of the surveyed population is 43 percent with 54 percent and 33 percent respectively among males and females. More than 80 percent of the urban population is literate and only 37 percent among the rural.

#### **Educational Status**

For the purpose of this survey persons 3 years of age or more were classified into three groups based on the educational status; never attended school, have attended school in the past and currently attending school as shown in table 4.1. Table 4.3 deals with the age specifics boys and girls between (6-19) years of age cross, classified into in school and out of school. The lower age group (6-12) years have been fixed as primary school going age children, (13-14) years as Lower Secondary school age, (15-16) years as Middle Secondary school age and (17-19) years as Higher Secondary school age in context of Bhutan. Based on the classification Net and Gross Enrolment Rates for the estimated surveyed population have been calculated. Also an attempt had been made to enumerate the reasons for currently non-school going children between (7-17) years of age and assessment of the existing schooling facilities.



#### CHAPTER - V

#### HEALTH AND FAMILY PLANNING

Maintaining the good health of the household members is very important for the well-being of the household. The BLSS collected data on the current status of health of the household members is based on their responses of whether the respondent suffered from sickness/injury prior to four weeks of the survey. The survey also collected information on the use of health facilities as well as some information on the use of family planning methods and fertility of women of reproductive age (15 – 49 years). Tables are constructed to show the health status of the total surveyed population on sickness or injury during the four weeks prior to the enumeration day. Persons who suffered from sickness or injury were classified by their attitude towards health services. Persons who did not consult with any of the institutions were further categorized by reasons.

Data collected for the reproductive women (15-49 years) covered pregnancy outcome and intentions on the use of health facilities during the pre-natal period. The survey also collected information about the knowledge and use of modern contraceptives, which has direct bearing on the pregnancies and sexually transmitted diseases. The survey estimated a total of 142707 Women (15-49 years) of which 13803 women gave birth during the 12 months prior to the survey period. More than 64 percent of the women of reproductive age know about modern contraceptives but only 44 percent of them used the methods. More than 55 percent of the women who had the knowledge and did not use the methods were been classified by age and the reasons as shown in table.

#### **CHAPTER VI**

#### HOUSEHOLD EXPENDITURE

Household expenditure for the BLSS data were obtained by adding the various goods and services purchased, consumed from own production and received as gifts. Consumption expenditure of all these goods and services reported in the different parts of the BLSS questionnaire was converted into values (Ngultrum), expressed as annual values, and then aggregated together to obtain a measure of annual household expenditure. The various components of consumption expenditure used to construct this aggregate had been grouped into three main groups: (i) Food items, (ii) Non-food items and Housing Services. The specific items included in each component, as well as methodology is briefly outlined below.

### 6.1 Food Consumption Expenditure

Households consume food obtained from a variety of sources. The food consumption component was constructed from the data collected in Block 8 of the BLSS questionnaire; the food consumption module questionnaire contains separate sets of questions on (i) food purchased in the market place, including meals purchased away from home, (ii) food that is home-produced, (iii) food items received as gifts from other households, as well as (iv) food received from employers as payment in-kind for services rendered. The food purchases module contains questions on purchases of a fairly comprehensive list of food items during a relatively short reference period, i.e. the last two weeks and during a typical month. Data are collected on the total amount spent on purchasing each food item, and also on the quantities purchased, during the specified reference period. Calculating the food purchases sub-aggregate involve converting all reported expenditure on food items to a uniform reference period-one year and then aggregating these expenditures across all food items purchased by the household.

The survey also asked the total value of meals taken outside the home by all household members; this amount was also included in the food consumption aggregate.

Data were collected on both the value and quantity of consumption from home-produced. The home-production food sub-aggregate was calculated by adding the reported value of consumption of each of the home-produced food items in a manner analogous to that followed in the case of food purchases.

Consumption of food received as payment in-kind and gifts were added to the overall food aggregate. For the items where the quantities were reported in local units, were converted based on standardization of measurement unit survey by region specific to standard units. In case of households consuming non-zero quantities of a particular item with missing values and cases with inconsistent data on quantity and value (outliers of unit price), median regional unit prices were use to make imputations. Median was computed and used separately for purchased and own produced items.

# 6.2 Non-food Consumption Expenditure

Unlike many homogeneous food items, most non-food are too heterogeneous to permit the collection of information on quantities, BLSS collected data pertaining only on the value of non-food over the reference period. Data on purchases of non-food items were collected at different recall periods, i.e. over the past month, or the past 12 months, depending on how frequently the particular items were typically purchased. Constructing the non-food aggregate thus entails converting all those reported amounts to a uniform reference period of one year, and then aggregating across the various items. The non-food consumption aggregate was constructed using data collected in Block 9, which included expenditure on clothing and footwear, transport and communication, household

operations, recreation, furnishing and equipment, and miscellaneous. The non-food expenditure also included expenditure on housing, education and health.

## 6.3 Housing

The estimate of the annual value of household expenditure on housing services was based on the data on the rental value of the dwelling. In case of the households renting their dwelling, the value of expenditure of housing services was taken to be the annual rental paid. In most cases, households own the dwelling and do not pay actual rent. These households were asked to impute the rental value of the dwelling unit in which they reside. Other household provided with housing free of charge (or at subsidized rates) by their employer or other entities were likewise asked to impute the rental value of the dwelling unit. In cases where households owning their dwelling were unable to provide a credible estimate of a rental value for their home (104 cases), the rental values were imputed to the dwelling by analyzing the materials used for the construction and based on the number of rooms for a particular location, rental value were provided. Based on the provided rental values for same construction material and the number of rooms in a specific location an average value was calculated and imputed for the missing rental values.

Total annual household consumption expenditure is obtained by aggregating together the three main components of consumption such as food consumption, non-food consumption and housing expenditures and remittances sent from the household was not included.

## Monthly Household Consumption Expenditure (MHCE)

The average monthly household consumer expenditure for Bhutan was estimated at Nu. 7362 with a monthly per capita consumer expenditure of Nu. 1728. The MHCE for urban and rural areas were estimated at Nu. 11125 and Nu. 6251 with corresponding MPCE of Nu. 2982 and Nu.1358 respectively.





## HOUSING, HOUSEHOLD FACILITIES AND ACCESS TO SERVICES

Housing is considered as one of the basic necessities of life besides food and clothing. The well-being of the population in general depends on the quality and adequacy of housing available. Besides, It is believed that the living condition of the people is directly affected by the structural characteristics, basic infrastructure facilities available to the households and their accessibility to services. Households are classified on the basis of the total time taken to travel to service facilities by mode of transport.

### Occupancy status of the housing unit

Majority of the households in the country own the living quarters. Table 7.1, shows that the proportion of households owning their living quarters is more than 76 per cent and only 23 percent occupy rented quarters. Households, that actually pays rent is more significant in the urban areas as compared to rural areas.





## I Concepts and Definitions

#### Household:

A household is a group of people who normally live together and eat their meals together. For this BLSS, 'normally is taken to mean that the person concerned has lived in the household for at least 6 of the last 12 months. Thus, the members of the household are identified on the basis of their 'usual place of residence'.

Note: A person who lives alone and makes his or her own meal arrangements is counted as a separate household.

## Assumptions to the definition of household:

1.The following categories of persons are counted as household members even though they have lived less than six months in the household during the past 12 months:

- a) School and college students who are living away from home in institutions (and who therefore have no chance of being counted elsewhere).
- b) Infants who are less than six months old.
- c) Newly married couples that have been living together for less than six months.
- d) Lodgers (guests) or other permanent residents who live and take their meals with the household.
- e) Servants and other paid domestic employees, if they live with the household.
- f) Persons who have recently joined the household, and are expected to live in this household permanently in the future.
- 2. The following categories are not counted as household members:
  - a) People who have lived in the household for more than six months out of the past 12 months but who are no longer members of the household (e.g. Because of death or separation).
  - **b)** People who live in the same dwelling, but do not share food expenses or eat meals together (e.g. two brothers living in the same dwelling, but having separate food budgets and separate cooking arrangements)
  - c) People eating together but who do not live in the same dwelling.

# **Definition of Household head:**

The head of household is the person who manages the income earned and expense incurred by the household and who is the most knowledgeable person concerning other members of the household.

If the head of the household is not present or available (for example, he or she may be living abroad temporarily), then an alternative 'head of household' must be selected in consultation with senior household members. The following criteria (in priority order) can be used to determine who should be considered next as the head of household:

a) the person accepted as the head by other household members

- b) the person legally responsible for the dwelling ( owner or lease holder)
- c) the person who is the main income earner
- d) the person who does most of the household shopping
- e) the oldest member of the household

## Household Size:

The total number of persons in the household is the size of the household.

# **Expatriate Household:**

Household of non Bhutanese resident in Bhutan who is paid for by an agency other than the Royal Government of Bhutan or employed by private enterprise/organization/agency of Bhutan like the government of another country, international organizations like the United Nations, FAO, the World Bank etc. Households of non Bhutanese resident (has been residing in Bhutan for at least 6 months) employee of RGoB is included and not considered expatriate.
