Preamble

The Performance Agreement is entered into between the Director General and Officiating Chief Research Officer of the Socio-Economic Analysis and Research Division (SERAD), National Statistics Bureau (NSB).

The objectives of this Performance Agreement are:

- a) To establish clarity and consensus about annual priorities for the SERAD consistent with the 2016-17 Annual Performance Agreement (APA), NSB's 11th Five Year Plan and the Government's other priorities:
- b) To make the SERAD fully responsible for driving implementation and delivering the results against the annual priorities; and
- To provide an objective and fair basis for evaluating the SERAD's overall performance at the end of the year;

The Performance Agreement represents an important accountability mechanism for inculcating a performance based culture at all levels of government.

THEREFORE, the parties hereto agree as follows:

Section 1: Vision, Mission and Objectives

Vision

- · Support evidence-based policy/decision making in the country; and
- Be a key provider of world class statistical information.

Mission

- Provide timely, relevant and reliable statistics consistent with international principles and standard for effective decision making and monitoring; and
- Be a key provider of internationally comparable statistical information.

Objectives

- 1) To ensure availability of timely, relevant and reliable official statistics;
- 2) To institutionalize standard data collection system;
- 3) To enable effective and efficient public service delivery;
- 4) To provide effective and efficient direction and operational services;
- 5) To create a conducive environment for gender equality and child protection; and
- 6) To prevent corruption.

Mandates of the SERAD are to:

- 1. Contribute towards improving the analysis of data for guiding policy through multi-disciplinary approach, including qualitative methodologies;
- 2. Promote research culture and generate knowledge on socio-economic themes for wider public consumption; and
- 3. Contribute to the government's policy of creating a knowledge society.

The success indicator of the SERAD are to:

- 1. Timeline by which the research theme of high relevance to policy, planning and development identified and research report is published; and
- 2. Number of publications with sex disaggregated data by age, sectors and districts.1

¹¹This is a mandatory success indicator from NCWC reflected in S/CDPD, SERAD, PHGISD & CAID's APAs wherein divisions shall jointly publish minimum of three gender reports in total.
